**Stability:** Material Stable.  
**Incompatibility:** Avoid contact with strong oxidizing agents, steam, alkali or alkaline earth metals, and strong bases.  
**Hazardous Decomposition Products:** Carbon Dioxide, Carbon Monoxides, Halogens, Hydrochloric Acid, Hydrofluoric Acid, and small amounts of carbonyl halides such as Phosgene and Fluorophosgene.

**SECTION VII - HEALTH AND FIRST AID**

**PRIMARY ROUTES OF ENTRY & EFFECTS OF OVER EXPOSURE:**

**Eyes:** May cause irritation, stinging, redness, tearing, blurred vision, and frostbite.  
**Skin:** May cause irritation with redness, itching, and burning. Frequent or prolonged contact can result in defatting and drying of skin leading to dermatitis.  
**Inhalation:** Inhalation of mist can cause irritation of nasal and respiratory passages. Abusive or excessive inhalation may cause irritation to the upper respiratory tract, dizziness, nausea, irregular heartbeat, and other central nervous system effects.
